We represent and warrant that Minor is of good health, physically fit and trained for this competition and is not aware of any physical or psychological impediments to his or her participation in any physical activity, event, or use of any athletic equipment in connection with this competition (collectively, “Activity”). We acknowledge and agree that any Activity in which Minor engages carries an inherent risk of potential accident or injury. We agree that by engaging in such Activity, Minor does so entirely at its own risk and hereby releases and holds harmless Company and all of its respective employees, officers, directors, and agents from any and all liability and responsibility of any kind whatsoever related to or arising out of any Activity, including, but not limited to, any injury, loss, or damage to Minor, a third party, entity, or property.

Parent further represents, warrants and agrees that (a) Parent is the legal parent or guardian of the Minor, (b) Parent has authority to enter into this Waiver and Release, and (c) the Minor will not disaffirm or disavow this Waiver and Release on the ground that the Minor was a minor on the date it is executed or any similar grounds whatsoever. We agree that this Waiver and Release shall survive the execution and delivery hereof and shall be binding on Parent’s and Minor’s legal representatives, heirs, and assigns. We have read this Waiver and Release and are fully familiar with its contents.
